I understand that there is an inherent risk in surfing and the use of surfing equipment. I intend to be legally bound hereby, for myself, my heirs, executors, and administrators, hold harmless and release and forever discharge Hui O' Pohaku Park S-Turns Surf Club, all other sponsors, the and the County of Maui, the site, the State of Maui, and instructors together with their agents, from liability for injuries, death, or damages, whatsoever, arising from my presence or participation in this surfing contest. I attest that I am physically fit and physical able to participate in this surfing contest. 5. If you miss your preliminary heat, you will not be able to compete unless there is a vacancy in a heat at a later time in your division.
6. Parking is available at Pohaku Park (S-Turns) and is limited.
7. Prize Tickets, T Shirts, food tickets for the day will be handed out upon the check in.
8. ALL prizewinners MUST be present to win. In the even that the first called winner is not present after the "Going, going gone" signal has been heard, and the prize cannot be claimed by the announced winner, the prize will be automatically forfeited and a new ticket will be drawn and a new winner announced, until the prize can be given away.
